#### Our vision and mission

The Zoological Society of London (ZSL) is an international conservation charity, driven by science, working to restore wildlife in the UK and around the world. Our vision is a world where wildlife thrives and every role, every person in every corner of ZSL has one thing in common — we are all conservationists, and passionate about restoring wildlife.

### **ZSL's Western Congo Basin Programme**

ZSL's Western Congo Basin programme aims to tackle biodiversity loss across a transboundary area spanning Gabon, Cameroon and Republic of Congo over the next 7 years. The programme will deliver against three main objectives: 1) to develop economic opportunities through investment in nature in support of climate adaptation and resilience and poverty reduction; 2) to slow, halt or reverse biodiversity loss; and 3) to reduce greenhouse gas emissions and safeguard natural carbon sinks.

## Purpose of the role

The Sustainable Revenue Manager will coordinate and deliver ZSL's programme of work to deliver activities that contribute to sustainable financing of conservation within the West Congo Basin landscape. This role will work intensively with a number of 'pioneer projects' to provide technical and financial support, cultivating a pipeline of nature-based solutions initiatives, to develop sustainable revenue streams and attract investment. ZSL will focus on three economic sectors: (i) forest-positive commodities, (ii) natural carbon projects, and (iii) philanthropy, including philanthropic tourism. You may be working on sustainable cocoa supply chains, IPLC-led carbon projects, ecotourism and other sustainable financing approaches. This role will work closely with the Sustainable Revenues Lead and Sustainable Revenues Monitoring, Evaluation & Learning (MEL) Coordinator, as well as the wider BLF team.

## **Key responsibilities**

The duties of the role will include:

- Project Management: Ensure effective and efficient management of ZSL activities to address sustainable financing of conservation activities, including work planning, delivery of outputs, budgeting and technical and financial reporting.
- Technical Delivery: Deliver project activities on behalf of ZSL across the Western Congo Basin, including;
  - o Undertake policy, regulation and land tenure research and analysis
  - Calculate biodiversity and climate-related metrics with a focus on carbon sequestration and avoided emissions from forestry, agriculture and other land uses.
  - Develop quantitative models for projects to estimate project/business outputs, including carbon credits, biodiversity credits and commodity production volumes and revenues
  - Prepare project feasibility studies and design documents
  - Develop business models and project plans
  - Prepare concept notes, grant applications and pitch decks
  - Work with ZSL partners and external organisations to identify new projects which could sustainably finance conservation activities in the Western Congo Basin.
- Partnerships: Maintain positive working relationships with project partners, ensure project deliverables are met and share capacity and learning on sustainable financing of nature-based solutions projects in the Western Congo Basin.
- **Strategy:** Feed in and adaptively manage ZSL's strategy for sustainably financing conservation activities in the Western Congo Basin under the leadership of the Sustainable Revenues Lead.
- Monitoring, Evaluation & Learning (MEL): Work closely with the MEL coordinators to ensure data
  collection and analysis to help ZSL assess effectiveness towards our impact goals and aid adaptive
  project management.
- **Ethical conduct:** Ensure that all activities and personal conduct is delivered to the highest ethical standards, in line with ZSL policies and procedures.

The duties and responsibilities described are not a comprehensive list and additional tasks may be assigned from time to time that are in line with the level of the role.
