

Indicators and research protocols for assessing timber and pulp companies

ZSL's SPOTT research protocols guide us when undertaking assessments. The purpose of these research protocols is two-fold:

- 1) To ensure a fair and consistent approach to assessing all companies on SPOTT;
- 2) To set expectations for what environmental, social and governance (ESG) data companies should publish.

The table below shows the information used to assess each indicator according to our timber and pulp indicator research protocols. To score points for an indicator, the required information must be made publicly available on a company's website, within the company's annual reports, sustainability reports, presentations or other reports, on its parent company's website or on its subsidiary's website (if applicable). In certain cases, information can be made publicly available on a third party platform (referred to as "external sources" within the research protocols).
